HOW CAN YOU MAKE A **PLANNED GIFT?**

It is important to choose a gift that matches your philanthropic goals. A planned gift gives you the ability to commit to larger gifts while also receiving tax advantages that benefit you, your estate, and Lifetime Recovery.

There are several ways to make a meaningful planned gift:



Immediate Gifts

These gifts provide immediate benefits to Lifetime Recovery. Cash goes directly into the Reserve Fund, and stocks, bonds, property, and other such assets are sold, and the proceeds go into the Fund.



Bequests

You designate Lifetime Recovery as the beneficiary of your estate by will, trust or a beneficiary designation form.



IRA, Retirement Plaus or Life Iusurance Policies

Name Lifetime Recovery as a beneficiary of your retirement plan or of a new or existing insurance policy by completing a beneficiary designation form provided by your insurer.



Establish a Named Fund at Lifetime Recovery

Use outright or deferred gifts to establish a named fund. You and Lifetime Recovery write a letter of agreement and you will receive an immediate dollar-for-dollartax deduction when you fund it.



Charitable Gift Aunuity

This contractual agreement in which, in exchange for a minimum gift of \$10,000, Lifetime will make fix payments to you, another person, or two people for life.



Charitable Remainder Trust

An irrevocable trust that provides for and maintains two sets of beneficiaries. Income beneficiaries receive a set percentage of income for your lifetime from the trust. Lifetime Recovery receives the principal of the trust after the income beneficiaries pass away. This allows taxpayers to reduce estate taxes, eliminate capital gains taxes, claim an income tax deduction, and benefit a charity instead of the IRS.
